Superb Ireland seal series victory over Afghanistan

IRELAND sealed the T20I series against Afghanistan with a thrilling, rain-affected win in the decider at Stormont. The home side won the toss and elected to bowl first in the final game of the five-match series...



That left Ireland needing 56 runs in seven overs for a series win. Afghanistan began strongly and after Mujeeb Ur Rahman claimed the wicket of...

Andrew Balbirnie for just six runs. Paul Stirling and Lorcan Tucker put Ireland back on top but dismissal of Stirling brought Afghanistan back into it. He holed out off Mujeeb, having become the fourth man in history to the milestone of 3,000 T20I runs during his innings. Harry Tector punched his first ball for four, to ease the Irish nerves but the dismissal of Tucker put the game back in the balance. It was Ireland who held firm and player of the series George Dockrell sealed victory with two deliveries to spare, giving the home side a 3-2 series win.
